An entity incorporated as non-stock organization in the City of Manila and is not-for-profit organized under the laws of the Republic of the Philippines is subject to income tax but may secure tax exemption with the understanding that income tax exemptions are not granted unless there is no other applicable taxing jurisdiction and Manila is considered as the other applicable taxing jurisdiction. However, for those entities which are already registered with the SEC as a non-stock religious institution or church in the Philippines, income tax exemptions are not granted from the beginning. A corporation, institution, association or church may apply for income tax exemption from the Bureau of Internal Revenue (BIR) by filing Forms I-C and I-D, which will be subjected to revalidation of the income tax exemption. the constitutional authority of the state to tax income and its use of that power to the public benefit in the maintenance of a healthy, efficient, and harmonious society is recognized by the united states supreme court in: jersey shore public service company v. new jersey, 479 u.s. 121 (1986); south carolina v. baker, 485 u. 505 (1988); and united states v. carlton, 512 u. 26 (1994).

the supreme court has emphasized the importance of state income taxation, especially in a political system in which the state regulates the economy. the court has said that states have a legitimate interest in raising revenue to support the government and to meet the public needs and obligations. the court has also said that the state has a legitimate interest in protecting the public against those who abuse the privileges of the state by engaging in fraudulent, deceptive, and misleading conduct to avoid tax liability. based on the interpretation of the supreme court of the united states of income taxation and its use to benefit the public, the state of new jersey found that its income tax laws which were intended to benefit the people did not violate the equal protection provisions of the fourteenth amendment to the u.s. constitution, since the state's purpose was to raise revenue to pay for governmental services and functions. see, also, indiana v. delaware, 577 u. ___ (2015). a religious institution or association or church is entitled to the income tax exemption if: the institution or association or church is organized and operated exclusively for religious purposes; the income of the institution or association or church is devoted exclusively to religious purposes; and the income is used exclusively for the welfare of the institution or association or church. 5ec8ef588b
